# April 2020 public exhibition Your Say Inner West page content

We're harmonising our approach to planning and development across the Inner West with the draft Inner West Local Environmental Plan (LEP) 2020. Tell us what you think of the LEP and help us move towards a cohesive planning system for our Local Government Area (LGA).

## What is happening?

Draft Inner West Local Environmental Plan 2020

We currently use three different LEPS which apply to the former Ashfield, Marrickville and Leichhardt Council areas and set out the rules for land use and development.

These have been consolidated to form the <u>draft Inner West LEP 2020</u>. Having a unified LEP for planning and development in the Inner West will:

- Simplify the planning process
- Provide consistency by aligning land uses and controls
- Provide a framework for a more comprehensive LEP and Development Control Plan (DCP) to be developed in the near future

Key principles which guided the process include the retention of zones and permissibility of land uses, harmonisation of the former LEP elements, consistency with strategic directions, and the support of sustainable outcomes.

Some changes to the LEP include:

- Rezoning the majority of industrially zoned land around Moore Street, Leichhardt from IN2 – Light Industrial to IN1 – General Industrial. Read the Moore Street rezoning fact sheet
- Rezoning the central portion of Ashfield Town Centre from B4 Mixed Use to B2 Local Centre. Read the Ashfield rezoning fact sheet
- Permitting light industries such as creative makers in some business zones
- Ensuring our centres have active uses at street level by restricting residential development to upper floors
- Prohibiting dual occupancies in residential zones

Review all proposed changes in our <u>frequently asked questions</u> and <u>view new LEP maps</u>.

#### **Updates to Development Control Plans**

Development Control Plans (DCPs) are design and planning guidelines which support the LEP. The existing Ashfield, Leichhardt and Marrickvile DCPs have been updated as part of this work to be consistent with the draft Inner West LEP 2020. Notification requirements have been removed from each DCP as these are replaced by Council's new Community

<u>Engagement Framework.</u> It is also proposed that control C25(c) of the Leichhardt DCP 2013 relating to car share provision be deleted.
