Callan Park is Not for Sale

Dear resident,

Callan Park is at risk.

The NSW Government released the Exposure Bill; Greater Sydney Parklands Trust on Friday 1 October. It is proposing changes to the way Callan Park is managed.

This is privatisation by stealth – gutting the Callan Park Act for commercial gain.

Commercial leases of up to 50 years would be offered for some of the most iconic buildings on the site.

The Government wants to remove council as the consent authority and change the Callan Park (Special Provisions) Act 2002.

This will result in privatisation and commercialisation.

This is what the Inner West has been fearing for 20 years – that the NSW Government will sell off Callan Park to the highest bidder.

We strongly encourage you to attend the Public Meeting which will be held online in MS Teams on Wednesday 27 October, 6pm–7.30pm, to hear important information about the Bill, and on what Council is doing and how to make a submission. You will hear from Friends of Callan Park, Ward Councillors and specialist council staff.

**Stop the Western Harbour Tunnel

The Western Harbour Tunnel project is a disaster for the Inner West. It brings no benefits and significant negative impacts to our local area and we need to do all that we can to stop it.

Please join us at a Public Meeting – online using MS Teams on Thursday 11 November, 6pm–7.30pm to hear important information on the Western Harbour Tunnel and its likely impacts on our local area. Hear from local specialists, specialist council staff and Ward Councillors. Find out also what Council is doing and how you can help stop the Western Harbour Tunnel.

Concerns about the Western Harbour Tunnel include:

- Dredging contaminated sediment from the harbour floor which will pollute Dawn Fraser Baths and threaten Sydney Harbour's marine life
- Three unfiltered exhaust stacks linked to WestConnex and the Western Harbour Tunnel, with one located next door to Rozelle Primary School
- Shallow tunnelling under highly valued heritage conservation areas
- Closing Yurulbin Point in Birchgrove to the community for four-and-a-half years

We urgently need a comprehensive health study on the documented impacts of WestConnex and the predicted impacts of the Western Harbour Tunnel.
