The revised application

Council has received an application for demolition of existing structures and construction of a boarding house. The application has been recently amended by the applicant and is now seeking demolition of existing structures and construction of a boarding house containing 97 boarding rooms (including on-site managers rooms) over 1 basement level of parking.

How it will be determined

The application will be considered and determined by the Inner West Local Planning Panel, a State Government constituted panel which is independent of the Council.

How to attend the Panel meeting

The Panel meets once a month (via online teleconference) and is made up of a state-appointed chair, two additional members from a state-allocated pool of experts, and one local person from a group of community representatives appointed by Council.

Anyone who makes a written submission will be notified of the Planning Panel meeting date when confirmed and invited to register to attend and/or speak at the meeting.

How to attend or speak at the Panel meeting

The meeting will be held online via teleconference. Registered attendees may address the meeting, although the Panel has adopted limits on the number of speakers for and against each agenda item. A final decision about limiting the number of speakers or the time allocated to each speaker will be a matter decided upon by the state-appointed Chair based on time constraints on the day of the meeting and fairness to other attendees.
